Ms. Wessing opened the floor for nominations for vice chair of MOSERS Board for 2025. Mr. Findlay nominated Ms. Jacobs for vice chair. Mr. Metzger seconded. Mr. Findlay moved nominations cease and Ms. Jacobs be elected by acclamation. Mr. Metzger seconded. Motion carried.

Ms. Spieler discussed a proposed amendment to the FY25 budget for legal expenses. Mr. Findlay moved to approve the amendment. Ms. Jacobs seconded. Motion carried.

The Committee recommended that the Board approve the proposed revisions to the Executive Director Performance Evaluation Scorecard. Mr. Findlay moved to approve the proposed revisions to the Executive Director Performance Evaluation Scorecard. Ms. Jacobs seconded. Motion carried.
