

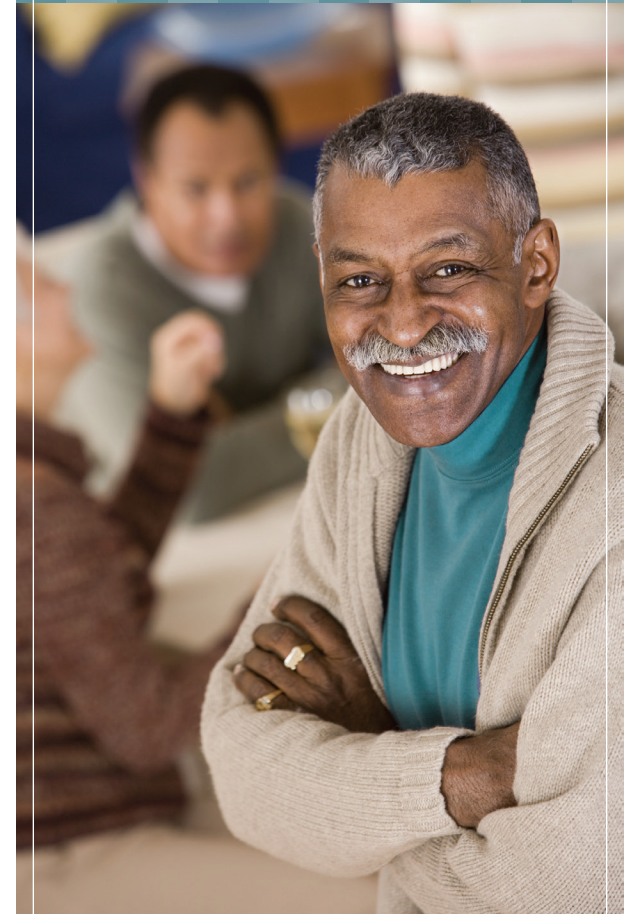
## MOSERS *Retiree Connection*

## What It Is

MOSERS *Retiree Connection* is a small group of retirees (15) representing regions all across Missouri who meet 4 times each

year. This allows MOSERS to touch base with retirees, discuss issues of current interest, and develop a group of informed retirees who we can contact (or who can contact us) when rumors or concerns arise that affect MOSERS retirees. In addition, this group may serve as a resource for other training activities and focus groups. (MOSERS will reimburse you for mileage if you are more than 50 miles from the meeting location.) In addition, you may occasionally be asked to review information we send you.

## What It Is Not

The *Retiree Connection* is not a lobbying group or political action committee. The MOSERS Board of Trustees has set specific guidelines for staff to follow in connection with proposed legislation. MOSERS' staff may provide technical comments and fiscal information as needed. When appropriate, staff may provide an unbiased analysis, including the pros and cons of proposals. We generally do not take a position on proposed legislation (unless there are equity, legal or other similar concerns) and you will not be asked to do so either.
